



On this 10th day of July, 2008, (names) Amishi Parekh, Inc. (hereinafter referred to as “Artist”) and (name) Yancey Strickler / J. Edward Keyes (hereinafter referred to as “Interviewers”) contract and agree to the following:

1.) ENGAGEMENT:

(Venue) Pitchfork Music Festival

2.) SCALING:

(Ticket Price): \$50 festival pass / All ages
(Sellable capacity): 30,000
(Gross Potential):

3.) ARTIST NAME: Amishi Parekh

4.) DATE OF ENGAGEMENT: 7/19/2008 – 7/20/2008

5.) TIMES:

6.) THE DEAL: \$23,250 guarantee + flight + hotel room for artist and entourage + local ground transportation + pleasant demeanor while dealing with artist (24/7). Payment in US funds will be paid by Interviewers no later than immediately following Artist's performance. Interviewers agrees to provide receipts and documentation of all show expenses (i.e. production, support and all catering expenses). Any expenses not advanced will not be accepted. No checks!

8.) BILLING ORDER: Amishi Parekh

No other artists can be added to the above bill without prior approval. Any misspelling of artist's name will incur a \$100 penalty.

9.) HOSPITALITY: Please refer to Artist rider.

10.) NO REPRODUCTION OF PERFORMANCE: No portion of the performance rendered hereunder may be broadcast, recorded, filmed, taped, or embodied in any form for any purpose of reproducing such performance or part thereof without Artist's prior consent. It is understood to include members of audience, press, and all Interviewers and venue staff. Disposable cameras only will be allowed.

10.) SECURITY REQUIREMENTS: Road manager will meet with the head of security and staff before doors open up to cover band's security needs. A safe, sturdy barricade must be used in front of the stage. Artist reserves the right to relieve any security or staff person from further duties for the remainder of the engagement if Artist deems security or staff person's actions detrimental to Artist, other performers, crew, patrons, or Artist's performance. Stage security and dressing room security must be an outside (t-shirted), private security company and cannot be police or local law enforcement.

11.) CANCELLATION:

Interviewers agrees to pay a cancellation fee of fifty percent (50%) of the agreed compensation to artist in the event that this engagement is cancelled by Interviewers for reasons other than riot, epidemic, strikes, an act of God, or other legitimate reasons beyond Interviewers's control. In the event of sickness or of accident to Artist, or if a performance is rendered infeasible or impossible by an act or regulation of any public authority or bureau there shall be no claim for damages by Interviewers and Artist's obligations as to such performance shall be deemed waived.

12.) INDEMNIFICATION:

Interviewers agrees to indemnify Artist, contractors, employees, and agents of Amishi Parekh, Inc against and from any costs (including attorney’s fees and court costs), claims, expenses, liabilities, damages, losses, or judgments arising out of, or in connection with, any type of claim, action, or demand made by any person or third party, if any are sustained as an indirect or direct consequence of engagement. Interviewers also agrees to indemnify Artist, contractor, agents, and employees against and from any and all loss, damage and/or destruction occurring to its and or its contractors, employees, agents, Artist’s instruments and equipment at place of performance.

13.) INSURANCE:

Interviewers shall provide Commercial General Liability Insurance with limits of liability no less than One Million Dollars (\$1,000,000.00) for each occurrence insuring against death and bodily injury arising from the negligence of Interviewers as promoters and operators of the Venue. Such insurance will name Producer/Artist as additional insureds as well as contractors or subcontractors hired by the Producer/Artist. In addition, Interviewers shall maintain in effect Worker’s Compensation Insurance covering all of its employees.

14.) CONTRACT/DEPOSIT INFORMATION:

Signed copies of all contracts, riders and (**\$2325 deposit**) must be received no later than **7/11/08** or Artist/Artist’s representative reserve the right to void this contract and cancel engagement. Artist to receive one hundred percent of gross over capacity. The validity, construction and effect of this contract and attached rider (s) shall be construed, governed and hereby interpreted pursuant to the laws of the state of New York. All riders attached hereto and hereby made part of this contract.
